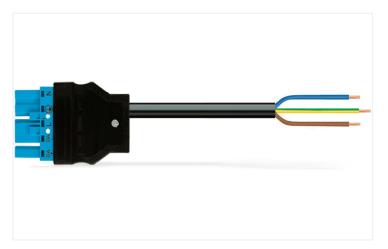
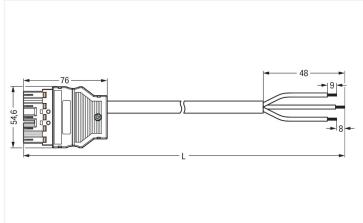

The cable assembly is halogen-free. This eliminates the addition of environmental pollutants during production. It also increases the fire class, since halogen-free materials are flame-resistant.
