Easyclick Aerial Module
Installation & operating instructions



The aerial module is part of the PEHA Easyclick (EC) system. The aerial module was developed as a gateway between the PEHA Easyclick EnOcean products and the Centraline HAWK controller. The communication protocol between HAWK controller and the aerial module gateway is defined in a special software driver what is available for the Arena AX software.

The signals are transmitted over the European harmonized frequency 868.3 MHz

The Easyclick aerial module receives and checks the EnOcean radio telegrams from EnOcean radio transmitters and EnOcean repeaters within the transmission range. The radio telegrams are forwarded through the RS485 bus to the HAWK. Similarly, any RS485 Message from the Hawk shall be broadcasted on the EnOcean network.

- Receive and transmit radio telegrams (bi-directional)
- Any number of radio transmitters can be received
- Max 50 EnOcean Devices (1 channel) per system.
- Max 32 antennas per HAWK in the RS485 bus.
- EnOcean TCM 300 (Dolphin Inside)

Notes:

- Read through the operating instructions carefully before putting the device into service.
- The aerial module must be connected to ensure full functionality of the system.

LED Displays

LED Off	No reception of RS485 messages
LED blinks green	Reception of RS485 Ping Messages from Hawk

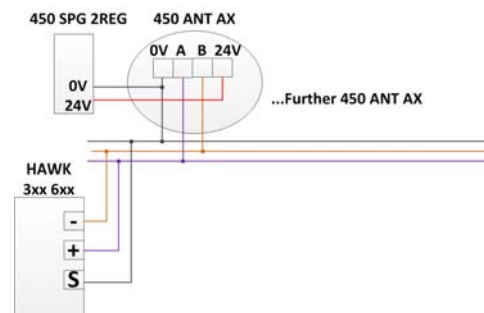

Operation

In Order to ensure the Antenna is powered ON, press the On Board button for 2 seconds. The Antenna beeps for a second and green LED blinks on the Antenna.

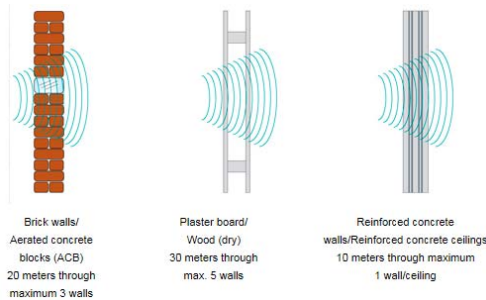

A justifiable deficiency is deemed to exist if the device exhibits a structural, manufacturing, or material defect that makes it unusable or substantially impairs its utility at the time it is turned over to the end user. The warranty does not apply to natural wear, improper usage, incorrect connection, device tampering or the effects of external influences. The warranty period is 24 months from the date of purchase by the end user from a dealer and ends not later than 36 months after the device's date of manufacture. German law shall be applicable for the settlement of warranty claims.
