**EU / UK Declaration of Conformity Transition statement**

1. CE marked goods that are self-declared or where any mandatory third-party certification is issued by an EU Notified Body will continue to be compliant for the GB market until the end of 2021, with no changes to documentation etc. From 1st January 2022 goods placed on the GB market will require UKCA marking although in all cases this can be affixed to packaging or accompanying documentation during 2022.

2. CE marked goods that are self-declared or where any mandatory third-party certification is issued by an EU Notified Body will continue to be compliant for the NI market indefinitely with no changes to documentation etc., without any requirement to add UKCA marking from 2022.

3. Details of the Economic Operators for individual markets may need to be added to goods as Distributors of goods placed on the GB or EU market will typically become Importers, requiring their name and address to be affixed to the product, its packaging or documentation. Alternatively, an Authorised Representative may be appointed within the EU27 by the Manufacturer.

We have adopted the later approach to setup an Authorised Representative inside the EU27 so our customers can carry on supplying our products knowing everything has been taken care of.

4. Ventilation products have to comply with the Low Voltage Directive(2014/35/EU) and/or the Electrical Equipment (Safety) Regulations 2016, these Directive/Regulations state that the "Manufacturer", having detailed knowledge of the design and production process are best placed to carry out the conformity testing in order to "self certify" the product to apply the CE / UKCA mark.

We produce the required technical files which are held with our "authorised EU representative" at the address above inside the EU27.

Directive 2014/35/EU does not require mandatory third party testing by a notified body within the EU27.
